### **3. Administrative fees**

Calculation for the sum of administrative fee which depends also on the number of presentations which are applied for is: 3.55 EUR + X (No. of different presentations: pharmaceutical forms, strengths and pack sizes) x 14.18 EUR. The same rule applies for renewals and variations, if the application requires change of Marketing authorisation, SmPC, PIL or Labelling. If the minor variation does not require change of the MA, SPC, PIL or Labelling, then administrative fee is 3.55 EUR.
